53rd Annual Crafts by the Dock

September 7 & 8, 2024

The Port Townsend Arts Guild's Crafts by the Dock arts and crafts fair will be held Saturday and Sunday, September 7 & 8, 2024 on Madison St. at Water St. in downtown Port Townsend. The fair is one block from the main entrance to the Wooden Boat Festival. Hours are 10am-6pm on Saturday and 10am-5pm on Sunday.

Available booth types are:

10' X 10' (doubles may be available) \$210

4' X 4' card table space \$70 for one day or \$110 for two

Non-Profit card table space \$30

Plus a \$5 annual PTAG membership fee payable with your first fair each year.

There are about 65 booth spaces on Madison St. and on the Civic Plaza.

Your entire display must be contained within your space. Card table spaces are limited to and for card tables only. Umbrellas are not allowed for any booth or table space.

- Electricity is not available at this fair.
- The Arts Guild does not provide canopies or tables
- Your booth must be able to withstand high wind and rain. Leg weights of at least 40lbs. are required. Lightweight shade canopies, and umbrellas are not allowed. No staking is allowed.
- PTAG provides security on Friday and Saturday nights from closing until 7am. However PTAG nor the City of Port Townsend will be responsible for any loss or damage, however caused.
- No ready to eat or drink items are to be sold.
- Music vendors must be prepared to offer headphones to their customers.
- Setup starts after the spaces are marked on Friday, usually about 6pm. Please be considerate and unload quickly and move your vehicle before setting up. There are many people here.
- If you are unable to attend, please contact us as early as possible. We have a waitlist. No shows, late arrivals, and early departers will not be welcome back.
- \$50 will be deducted from your booth fee if you cancel before July 1st. There are no refunds after that date.
- Your check will be cashed when you are accepted, returned if you are not accepted and you
 will be contacted if you are accepted but the fair is full and you will have the option of the
 waitlist. General set up information is available on the website and particulars will be emailed
 or sent prior to the fair.

To apply, send 4 photos of your work and 1 of a stocked booth either by USPS or email. Email photos directly to us. Do not refer us to a website. **Mail your application with your check**. Artists who have participated in a PTAG event in the past 3 years do not need photos unless your work has changed or to be considered for publicity. Photos will not be returned. YOU must make all that you sell. No kits, imports, or resale items. Please describe your art or craft in detail on the application if you are new. Limits will be set in each category for diversity. As important as the search for talent is, we do not lose sight of the need for artists who are cooperative and easy to work with. No amount of talent or ability will compensate for this. Previous participation does not guarantee a space. Applications will be considered until the fair is full. Acceptance is on a first- come, first- served basis. Sending application materials in oversize envelopes and packages may slow receipt.
